

**Minutes of  
Regular Business Meeting  
Texas Alliance of Groundwater Districts  
January 15-16, 2025  
Courtyard by Marriott Pflugerville**

These minutes are a record of the items discussed, including motions on any matters that involve the Texas Alliance of Groundwater Districts (TAGD) Membership. The minutes mostly follow the order on the previously distributed agenda, but may not have been discussed in that order, as noted in the minutes.

- Call to Order and Welcome.** President David Bailey called the meeting to order at 1:01pm. David invited Zach Holland to provide an invocation.

- B. **Roll Call.** Secretary Stephanie Keith conducted the roll call, confirming the attendance of 53 members, which established a quorum necessary for conducting official business. A list of districts present at roll call is attached to these minutes.
- C. **Membership Update and Announcement of New Members.** President David Bailey announced that we currently have 87 GCD members and 38 associate members. President David Bailey asked for introductions of first-time business meeting attendees.
- D. **Discussion and Possible Action on Minutes of Prior Meeting.** President David Bailey presented the meeting minutes from the August Regular Business Meeting. John Martin made a motion to approve the minutes as presented. Britney Britten seconded the motion. The motion passed unanimously.
- E. **TAGD Annual Report.** Executive Director Adam Foster presented the 2024 Annual Report.
- F. **Discussion and Possible Action to Approve FY24 Q4 Finances.** President David Bailey asked Treasurer Janet Guthrie to present the FY24 Q4 finances. Janet Guthrie presented the Q4 finances, which had been reviewed and endorsed for approval by both the Finance & Budget Committee and Executive Committee, to the membership. David Van Dresser motioned to approve the Q4 finances as presented. Gary Westbrook seconded. The motion carried unanimously.
- G. **Speaker Series.** Executive Director Adam Foster introduced the speakers invited for the afternoon Speaker Series. The following presentations were provided: *"Hydrogen Electrolysis"* by Pradeep Venkataraman, Sr. Technical Director, AES Clean Energy; *"USGS Groundwater Updates"*, Natalie Houston, Hydrologist, USGS; *"Maverick Basin Aquifer Overview"*, Gerry Grisak, Principal Hydrogeologist, Intera.

Following a short afternoon break, Executive Director Adam Foster reconvened the meeting at 3:30pm and introduced the next speakers. The following presentations were provided: *"Legislative Outlook"* a panel discussion by Robby Cook, Principal, Riceland Consulting LLC; Sarah Kinkle, Director of Policy and Legislative Affairs, Texas Water Association, and Shauna Sledge, Attorney, SledgeLaw Group PLLC; *"BLF Land, LLC v North Plains GCD Overview"* by Deborah Trejo, Attorney, Kemp Smith Law.

At the conclusion of the speaker series, Executive Director, Adam Foster, recessed the meeting at 5:30pm and invited members to the TAGD reception.



- J. Discussion and possible action on the Honorary Membership nomination of Ronnie Hopper.** President David Bailey announced that TAGD has received a nomination for an honorary membership for Ronnie Hopper. The nomination was previously approved by the Executive Committee for recommendation to the TAGD members. Adam Foster shared highlights of Ronnie's dedicated service and retirement. Amber Blount, Dirk Aaron, provided endearing comments. A motion to approve the membership was made by Louis Pena. David Van Dresser seconded the motion. The motion carried unanimously.

**K. Other TAGD Business.** President David Bailey asked members if there was any other TAGD business to discuss.


